


Update on progress

- Since the last meeting on 11th April, we have closed five defects.
- Change 307 deployed partially successful, providing earlier visibility of K89 record mismatches for additional supporting information files.
- Amendment Invoice ASP & AML files The way forward workshop was held on Thursday 12th April. No reduction in the scope of the supporting files was identified.
- Defect information published on Xoserve.com on 20th April. Increased visibility and discussions are proposed to be held through DSG.
- Additional stream of work initiated to review the underlying architecture used in the creation of ASP/AML files.


