This Change Proposal (CP) is to request approval for a number of amendments to the Service Description Table as detailed below.

Service Lines that have been superseded

In 2020, following consultation with its Customers, Xoserve carried out a Cost Allocation Review, which required updates to several CDSP DSC Service Documents.

The review led to the original 22 service areas in the Budget and Charging Methodology being replaced by 13 Process Journeys.

As a result, several service lines within the CDSP Service Description Table were moved to new areas, with new service line reference numbers created to reflect the new service area reference number. A new column was also introduced to show the reference in place up to and including 31/03/21, alongside the new reference effective from 01/04/21.

We are seeking approval to remove the original service line reference numbers because they are now redundant. For visibility, these references have been moved to a new tab in the table titled 'Superseded Service Line Refs'.
