A3: Proposer Requirements / Final (redlined) Change

Problem Statement:	UNC Modification 0872 creates a change to Gemini that enables eligible Users to elect to submit Single-sided Trade Nominations. This would mean that existing methods of trade clearing which involves nominating both client side and clearing house, logging in using customer (shipper) accounts is superseded. This method is at greater risk of erroneous entries and requires account data to be shared.
	Whilst the Gemini solution has been planned in preparation for the potential implementation of Modification 0872, there is a need for this change, specifically the administration and management of the solution, to be considered, with agreed processes documented outside of Code and linked to this Change Proposal.
Change Description:	The Final Workgroup Report for Modification 0872 / XRN5787 is being presented to Panel on Thursday 15 th August 2024.
	The ROM states that new functionality will be introduced into the Gemini system to place Single-sided Trade Nominations. The ROM identified two solutions in Gemini: 1) an API Only Solution and 2) an API plus Online screen Solution. Whilst the Gemini solution is clearly outlined along with forecasted timescale and cost range, the process to manage this introduced functionality needs to be considered. For completeness the latest version of the ROM is embedded within the document.
