



Gemini October 2025 Clock Change Supporting Information



Overview

- On Sunday, 26th October the clocks go back one hour at 02:00, marking the end of British Summer Time (BST) and the return to Greenwich Mean Time
- The clock change causes the 01:00 to 02:00 hour to occur twice—once in BST and once in GMT. This “repeated hour” introduces scheduling and data processing complexities
- To minimise the risk to customers from the clock change, several Gemini processes are being modified during the 01:00 – 02:00 GMT hour bar
- Please note that both APIs and user interface screens will be impacted during this period.
- The below process will be restricted with further details provided within the pack:
 - Within Day Auctions (Entry & Exit)
 - GB Renominations
 - EU Nominations
 - OCM & OTC Trades

Process Details for 01:00 – 02:00 BST Hour bar

- The Gemini system will operate under standard business conditions during the 01:00-02:00 BST hour bar, however processing times will be impacted. Specific processing rules for activities in this period are as follows:
- **Within-Day Auctions**
 - Bids placed during this hour will be processed at 02:15 (entry) or 02:30 (exit) GMT.
- **IP Trades and Transfers**
 - Trades/transfers submitted between 01:00 and 02:00 BST will be approved and processed between 02:00 and 03:00 GMT
- **IP Within-Day Bids**
 - This processes will run unimpeded.
- **Day-Ahead Nominations and Bids**
 - All day-ahead activities will run as expected.
- **GB Renominations**
 - Renominations placed during this hour will be approved at 02:25 GMT.
- **EU Renominations**
 - Renominations placed during this hour will be processed at 02:03 and 02:04 GMT.
- **OTC Trades**
 - Trades placed before 01:55 BST will be approved at 01:55 BST.
 - Trades placed after 01:55 BST will be approved at 02:55 GMT.
- **OCM Trades**
 - Trades placed before 02:00 BST will be approved

Process Changes for 01:00 – 02:00 GMT Hour bar

The Gemini system will offer restricted services during the first hour of GMT on gas day 25th October. The services impacted are shown below, with additional details in the following slides.

- **Within-Day Auctions**

- No bids will be able to be submitted for within day auctions in this hour bar

- **GB Renominations**

- The system will not allow GB Renominations to be placed during this hour bar

- **EU Nominations**

- The system will not allow EU Nominations to be placed during this hour bar

- **OTC Trades**

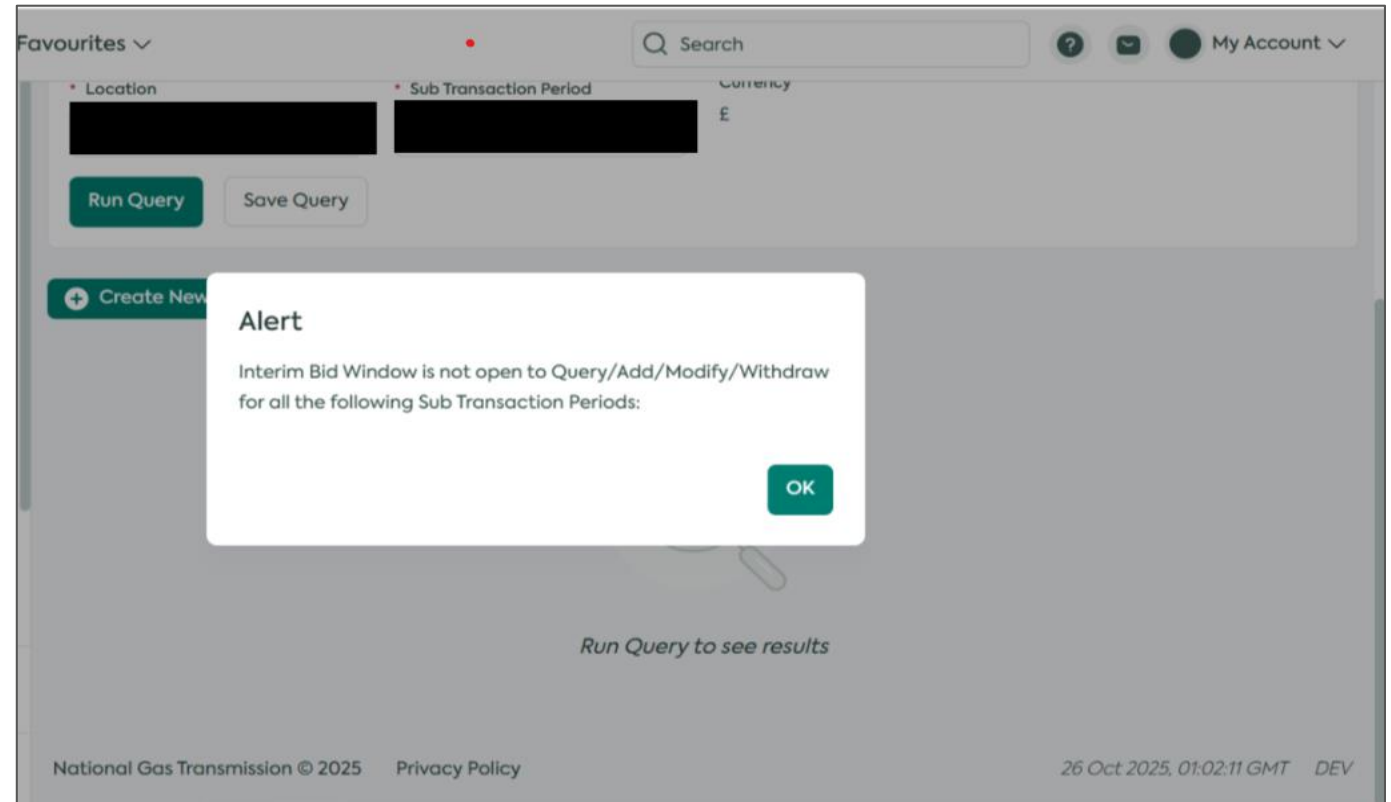
- The system will not allow OTC Trades to be placed during this hour bar.

- **OCM Trades**

- The system will not allow OCM Trades to be placed during this hour bar.

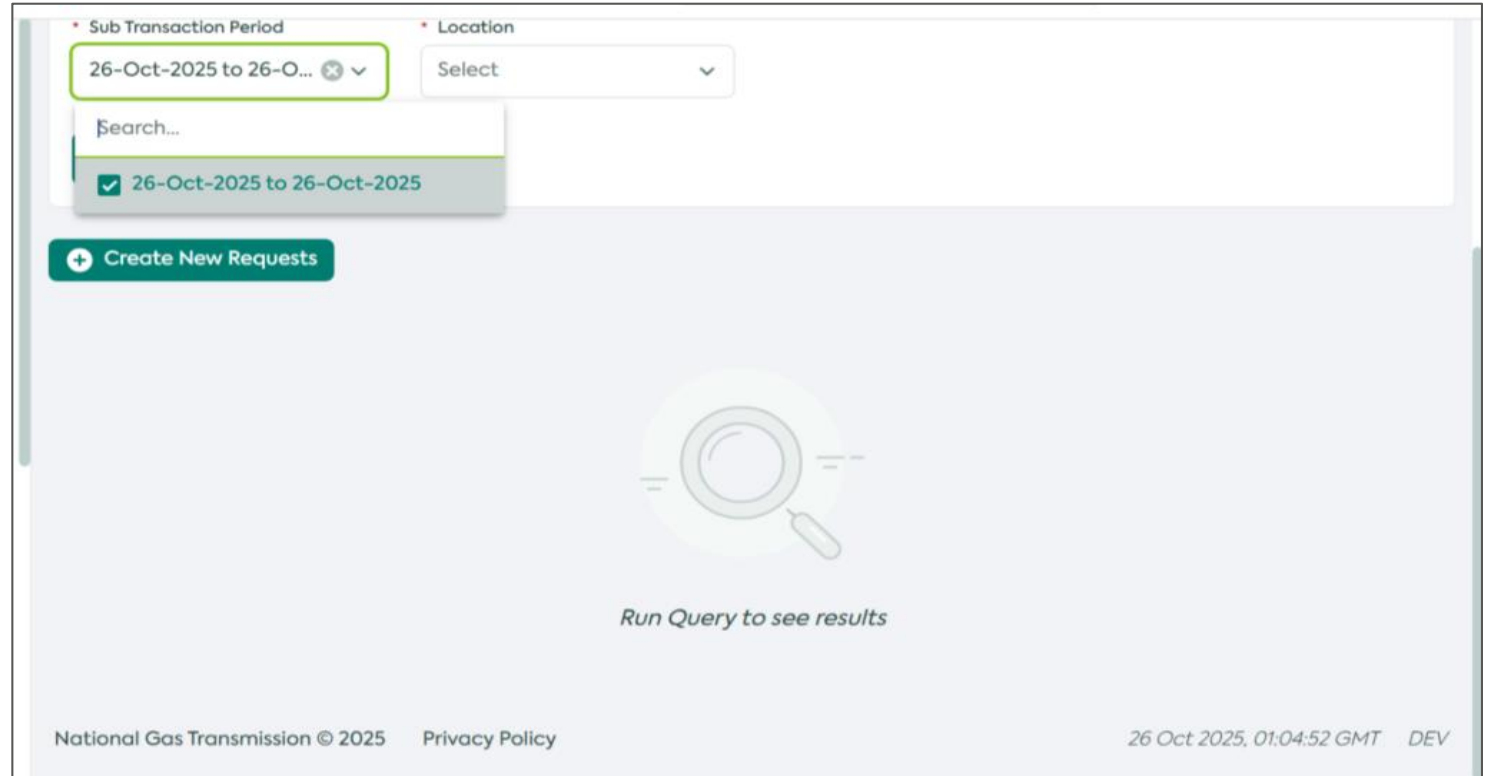
Within Day Auctions (Entry)

- Please note that when attempting to place bids for entry within day (25-Oct-2025), the system will display an alert message and will not permit bidding between 01:00 GMT and 01:59:59 GMT.

- Please note that when attempting to place bids for within day (25-Oct-2025), the system will display an alert message and will not permit bidding between 01:00 GMT and 01:59:59 GMT.
- The current gas day in the sub transaction period drop down will not be visible

- Please note that when attempting to place GB Renominations for Gas Day 25-Oct-2025, the system will display an alert message and will not permit between 01:00 GMT and 01:59:59 GMT.
- From 02:00 to 02:59 GMT, the window will be open as usual for any required renominations. Any renominations placed between 01:55 BST and 02:25 GMT won't be processed until 02:25 GMT.

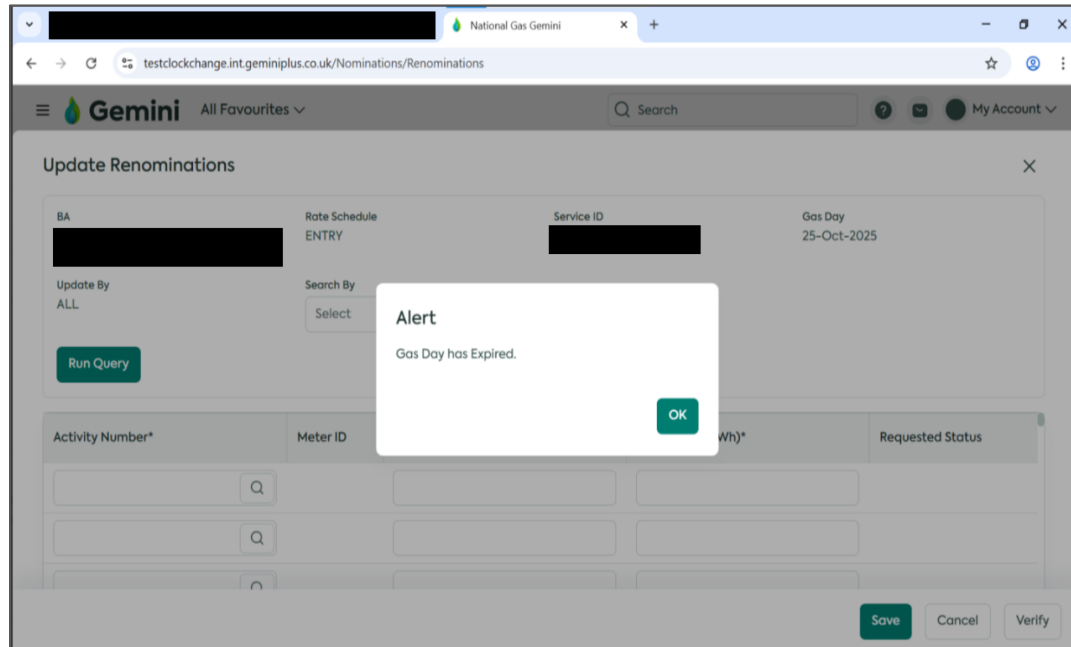

OTC Trades

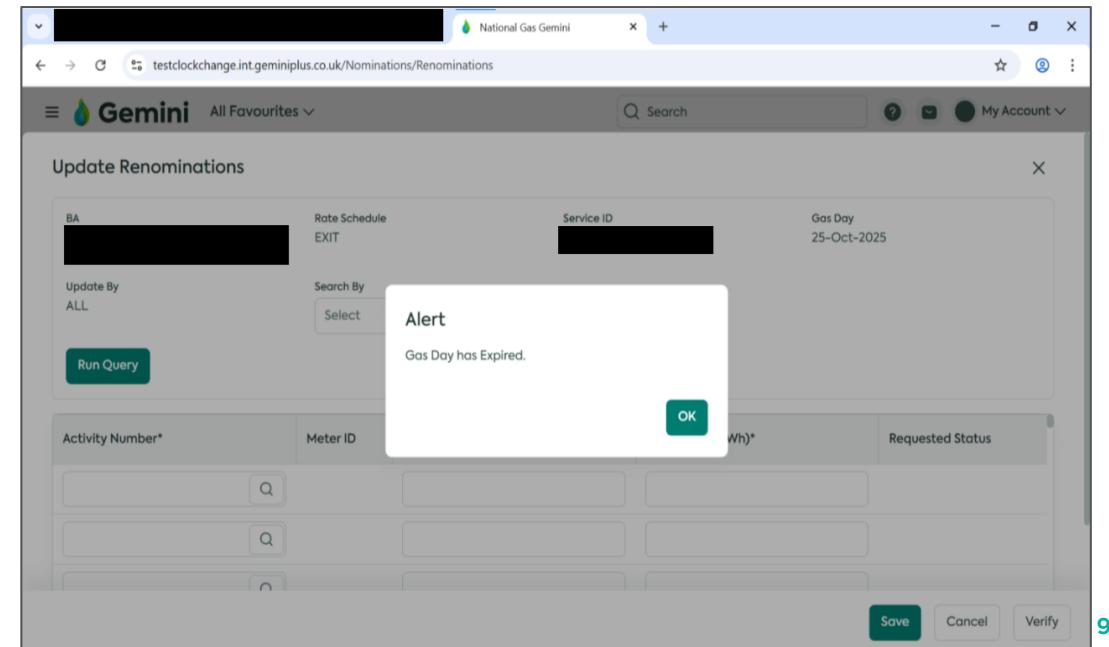
- Please note that when attempting to place OTC trades for the Gas Day 25-Oct-2025, the system will display an alert message and will not permit the OTC trade between 01:00 GMT and 01:59:59 GMT.
- From 02:00 to 03:00 GMT, the window will be open as usual for any required updates. Any trades placed before 01:55 BST in this hour bar will be approved at 01:55 BST, whilst any placed after 01:55 BST, but before 01:59 BST will be approved at 02:55 GMT.

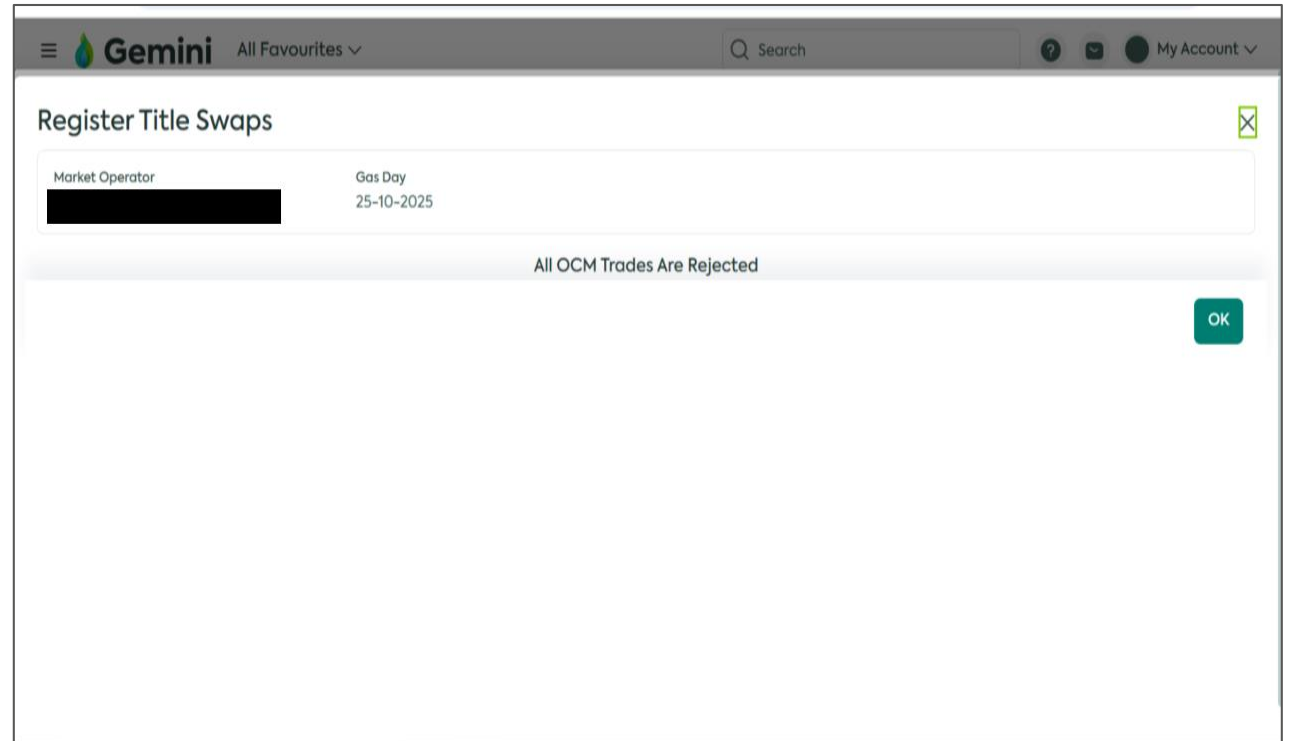
